## Nigeria Has Highest Number Of Out-Of-School Children In Sub-Saharan Africa

he Minister of State for Education, Mr. Chukwemeka
Nwajiuba, says Nigeria has the highest number of out-of-school children in sub-saharan Africa.

Nwajiuba stated this during the inauguration of 'Better Education Service Delivery for All (BESDA)' in Katsina recently.

He announced that Nigeria has an estimated 1-,193918 children, who are out of school.

According to him, the current challenges affecting the Nigerian education system has left much to be desired, saying that the system was characterized by high illiteracy level, infrastructural decay and deficits.

The minster stated that BESDA focused on 17 states, 13 of

# Sirika Present Concept Note on Aerospace, **Aviation Varsity to NUC**

The Honourable Minister of Aviation, Malam Hadi Sirika last Thursday, submitted a Concept Note to the Executive Secretary, National Universities Commission (NUC), Professor Abubakar Adamu Rasheed mni, MFR, on the Ministry's plan to set up an African University of Aerospace and Aviation, to be located in Abuja.

Speaking shortly, before presenting the Concept Note to the Executive Secretary, the Minister said that the establishment of the university was one of the strategic policies of the Ministry approved by President Muhammadu Buhari towards repositioning the sector, adding that already the sum of one billion Naira was provided in the 2021 budget for the takeoff of the new university.

Malam Sirika said that the special university would be dedicated to research and development in civil aviation and aerospace technology and disclosed that Nigeria would be the first country on the African continent to establish such an institution and that is why the name "African University of Aerospace and Aviation."

The Minister noted that aerospace and civil aviation had been expanded with new frontiers that "need the is producing aircraft, and we aren't producing a pin. So 1 think we should be able to have this university that is dedicated to aerospace and

attention of experts that Nigeria will begin to play a role and participate effectively."

He said: "An example is the development of drones or unmanned vehicles that have now taken over the space delivering cargo, delivering mails, delivering things and very soon delivering human beings and robots."

He explained thing at "This is a new frontier in civil aviation that needs to be developed," adding: "We started with Brazil is producing in the area of civil aviation, today Brazil

While noting that aviation had gone beyond skill acquisition, the Aviation Minister stressed that the University would not aerospace technology, Mr. Sirika said his team had sought the intervention and collaboration of Ivy League Universities in USA and Ukraine, with tack records in Aviation Studies and Management to glean from their best practices.

In his words "I have a personal emotion towards setting up the Aviation University. I realised that education is one instrument that can unbundle knowledge beyond a limitless

he said.

He argued that the university would serve as a single market of civil aviation and aerospace in Africa, being the first of its kind with the capabilities to provide robust research and development services in the ever dynamic and changing sector like aviation.

Mr. Sirika expressed gratitude to Executive Secretary and his team for guiding the process leading to the submission of the concept note and the assurance that it would be expeditiously concluded.

In his response, the Prof. Rasheed described the Minster as an adventurous person and knowledge seeker all his life. He said NUC was ready to assist government and private agencies interested in establishing universities especially specialised ones that would address specific needs.

He reiterated the commission's commitment to ensure that the guidelines for establishing any higher institution in the country were adhered to before granting approval. As an interim measure, he promised to engage some professors to perfect the concept note for immediate approval.

Prof Rasheed said: "I can assure you that by the end of the month (July), we are going to have a brand new University, the first African University dedicated to aviation and aerospace study in the country".

The Executive Secretary stated that the value of such university could hardly be quantified and commended the Minister for his boldness and courage.

"This aviation under your guidance will be the first to show the way that we can support the establishment of specialised university with the ideology of a 'trans-national education system', that won't only serve us but serve the African region and the international community." He said.

Also in the Minister's entourage were some Senior Directors in the Ministry, his Chief of Staff, Director-General, Nigeria Meteorology Agency (NIMet), Prof. Mansur Bako Matazu as well as Director, Public Affairs, Mr. James Odaudu.



management; leadership enhancement and capacity building as well as on Public Service Reforms.


He began his career in NUC in 1993 as Personnel Officer II, in the Establishment Division. In the course of his career in the Commission, he traversed the various administrative

# **BudgIT Foundation Seeks Data on University Management**

Welcoming the team, the Executive Secretary said that BudgIT was a serious organization and expressed the readiness and willingness of the Commission to honour requests from such serious organization like theirs interested in collaborating with NUC.

He informed the team that the functions of NUC as it concerned the Nigerian University System (NUS) include: advising the executive on the financial needs of universities, coordinating the development of universities in Nigeria, allocating and disbursing federal grants and external aids to universities, researching and advising government on topics relating to higher education

He said that NUC helps to foster partnership between the

This, according to her, could be further deployed with the increasing numbers of universities in the country with some unscrupulous elements trying to exploit any gaps in information to cause damage to the system. The Commission, she noted, might also wish to leverage on the reach of BudgIT to draw more attention to the preponderance of degree mills and illegal degree awarding institutions.

In respect to government funding of universities, she said BudgIT would become great partners by assisting in ensuring that correct information was in the public domain about how much government was already investing and how far the funding goes towards achieving the stated aims for the good of the system.

## NOTICE OF ILLEGAL UNIVERSITY OPERATIONS OF AL-NAHDA INTERNATIONAL UNIVERSITY IN NIGERIA

The attention of the National Universities Commission, NUC, has been drawn to the illegal operation of a so-called Satellite Campus of AL-NAHDA University, Niamey, in Gusau, Zamfara State purportedly awarding undergraduate Degrees to unsuspecting Nigerians.

The illegal AL-NAHDA Satellite, campus is located adjacent to the Zamfara State House of Assembly and has a Polaris Bank Account No. 4091289549, through which payment for its fees in Nigeria are made.

Further investigations by the NUC into the Operation of AL-NAHDA International University revealed that in Niger Republic, the University has campuses in Niamey and Maradi.

The NUC is, by this notice, alerting the general public to the Illegal operations of this institution and wishes to state categorically that all certificates obtained from it will not be recognized or be accepted in Nigeria for the purposes of NYSC, employment and or further studies.

NUC also wishes to advise state,

governments and the private sector to always cross check with the NUC before patronizing any institution purporting to award degrees in any part of Nigeria to avoid embarrassment.

For the avoidance of doubt, AL-NAHDA International University, Niamey, Gusau Satellite Campus is not known to the National Universities Commission which is the sole regulatory agency for all categories of degree awarding institutions in Nigeria and any Cross Border Education model operating in Nigeria.

Their activities violate the Education National Minimum Standards and Establishment of Institutions Act Cap E3 2004, an act which mandates NUC to close down all unapproved degree-awarding institutions.

Consequently, the Proprietors and Promoters of this illegal degree mill are by this notice directed to close down their illegal activities within 30 days. They are also to give the National Universities Commission notice of compliance within the stated period or be ready to face the consequences of their illegal operations.

I write at the behest of the Executive Secretary to Inform the Vice-Chancellors of all Nigerian Universities, that the Federal Government has, vide the attached Circular HCSF/3065/Vol.1/47 and dated 22<sup>rd</sup> December, 2020, issued by the Office of the Head of the Civil Service of the Federation, directed that Officers on Grade Level 12 and below should stay at home for a period of five weeks, effective from Wednesday, 23<sup>rd</sup> December, 2020.

Vice-Chancellors are to please note that the directive is part of the measures approved by Mr. President to mitigate the second wave of Coronavirus (COVID-19) infections in the country. The affected Officers are expected to perform their duties from home while those on Gl. 13 and above should strictly adhere to the extant preventive measures including maintenance of physical distancing, regular washing of hands and/or sanitizing of hands, wearing of face masks and reducing the number of visitors to offices. A copy of the Circular is attached for proper guidance and for Vice-Chancellors to ensure full compliance with the directives of the Federal Government, as appropriate.

I am to add that, in line with the directives of the Presidential Task Force (PTF) on COVID-19 on Monday, 21<sup>st</sup> December, 2020, all academic activities, involving large crowds (e.g. classrooms, hostel accommodation, conferences and seminars), should be suspended whilst the Universities remain closed during this intervening period, pending further directives by the Federal Government on the reopening of schools.

# **FME SAFETY GUIDELINES ON SCHOOL RE-OPENING**

- Safe distancing procedures
- Develop and display at schools, simple context-specific reference protocols on day to day actions to be operated in each school.
- Conduct risk assessment with a view to understanding the gaps in the system that can increase the risk of transmission and make recommendations for addressing the gaps
- Safety and hygiene in all stages and phases of the school reopening process, which promotes behaviors that reduce spread, such as school commutes (to and from school traveling), safe distancing, frequent hand washing and the use of facemasks.
- Other guiding frameworks include sensitization and monitoring procedures.
- Ensure adequate Water, Sanitation and Hygiene (WASH) facilities across the school premises
- Encouraging the use of open spaces for gathering and promoting outdoor activities.
- There should be regular temperature checks For all the visitors coming into the schools using infrared thermometers.
- Establish a staff/students committee for regular surveillance, monitoring, and enforcement of COVID-19 guidelines.

List of approved Distance Learning Centres in Nigeria, Twelve Universities in the Nigerian University System, currently have the approval of the National Universities Commission to operate distance learning centres as follows:

- 1. Distance Learning Centre, University of Ibadan.
- 2. University of Lagos, Distance Learning Institute.
- 3. University of Abuja, Centre for Distance Learning and Continuing Education.
