# **President Tinubu Commends UniAbuja for Maintaining Stable Academic Environment**

h e President, Commander-in-Chief, Federal Republic of Nigeria and Visitor to University of Abuja (UniAbuja), Asiwaju confronted the Nigerian University System (NUS), especially the recent industrial action that nearly stalled activities in the nation's University's Convocation Arena. The President, who was represented by the Acting Executive Secretary, National Universities Commission,

Bola Ahmed Tinubu, GCFR, has commended the University for its resilience in maintaining a peaceful academic environment for its students to pursue their academic programmes despite the numerous challenges that

campuses.

He made the commendation in his address at the 27th Convocation Ceremony of the University of Abuja, held penultimate Saturday ago, at the (NUC), Mr. Chris J. Maiyaki, called on the universities to shun industrial actions in order to bring harmony to the system, noting that strikes has been legitimate means of ventilating grievances but it should also take

place within the confines of internationally recognised labour laws.

He stressed that incessant strikes had its own crippling effect on the economy of a nation, particularly Nigeria's fragile economic system.

He said his administration remained committed to reinventing the economy and had put in some measures to enhance the welfare of both academic and

non-academic staff in Nigerian universities in order to ensure that such never happened again.

The President said that his administration would continue to support all aspects of education, with special focus on Science, Technology, Engineering and Mathematics (STEM), stating that no nation could achieve accelerated development without a stable and responsible University system.

He stated that Universities were vested with responsibility of training the necessary human capital to drive development. Furthermore, Universities conceptualize programme that assist government in policies aimed at poverty reduction, wealth creation, technological innovations, among others. Thus the academia plays an enviable role in governance, leadership, attitude amongst other indices.

Mr. President remarked that government alone cannot shoulder the burden of University education and that time had come for cost-sharing where parents and other stakeholders must be willing to share in the delivery of quality university education in the country.

In recognition of this, he said his administration recently signed the students loan bill so that indigent students could take advantage of it and pursue their dreams.

Mr. President stated that his administration has a liberal policy of education with the most recent innovations that includes the development of the new Core Curriculum and Minimum Academic Standards (CCMAS), in which Universities were allowed to develop 30% of the programme to suit their local

He concluded by stating that convocation was a solemn occasion designed to offer an opportunity to reflect on the past and evaluate one's activities.

He commended the graduands on the occasion of the glorious transition to the next phase of life and congratulated the recipients of the Honourary Doctorate

a d v a n c e m e n t o f t h e i r communities and committed to the pursuit of service to humanity. He congratulated the graduands for taking these vital steps in the journey of life noting they would never regret their action.

While delivering his address, the Chancellor of the University of Abuja, His Royal Majesty, Alhaji (Dr) Rilwanu Suleman Adamu, CFR, Emir of Bauchi, stated that the University has faced several challenges in recent years, including health, financial difficulties and infrastructural deficit.

He added that despite these challenges, the faculty and staff of the University had continued

to provide students with highquality education.

He acknowledged the support the University continued to enjoy from the government which he noted was evident in the physical structures that dot the main campus of the University, adding that due to its location in the

Federal Capital Territory (FCT), the University has unique challenges occasioned by huge demands on its services.

The Emir of Bauchi assured that the University would continue to make concerted effort to increase the internally generated revenue (IGR) to compliment government interventions.

He said "we are not unmindful of the current debate on financial independence of Universities; we will do whatever is necessary to ensure all stakeholders leave up to expectation".

The Royal father urged the graduating students to brace up for the challenges ahead of them by putting to use the world-class education they received from the University and equipped themselves with the knowledge and skills to make a difference in the world.

He also congratulated the

honorary doctorate awardee, Professor Toyin Falola, saying "your work in the field of knowledge and history has illuminated the lives of many. We are grateful for your dedication to improving wisdom for a better understanding of tomorrow. Your work has made a real difference in the world" he said.

The Vice Chancellor University of Abuja, Professor Abdul-Rasheed Na'allah, in his welcome address at the 27th Convocation ceremony of the University, stated that based on the approval of the Senate, the University was graduating a total of 7,034 students; 6,044 graduated with first degrees, 270 with Postgraduate Diplomas, 613 with Master's and 107 with Doctorate Degrees.

He added that 39 first Degree students graduated with First Class, 1,581 Second Class Upper Division, 3,702 Second Class Lower Division, 573 Third Class, and 149 graduated with Pass respectively. The university also graduated 87 students being its first set of Abuja Business School with a Master's in Business Administration (NBA) Degree.

Professor Na'Allah, noted that it was his desire to sustain the university's drive towards attaining a world-class status via a blend of purposeful community driven initiatives, recognition of excellence, and academic prowess.

He added that the restoration of full academic activities has enabled the University accelerate its academic expansion, adding that it has culminated into the establishment of four new Faculty namely, the Faculty of Communication and Media Studies, the Faculty of Environmental Sciences, Faculty of Nursing and Allied Sciences,

and the Faculty of Pharmaceutical Sciences.

The Vice Chancellor stressed that, following the successful outcome of the Resources Verification visit by various verification teams sent by the NUC, the department under the faculties were poised to immediately commence admission of students, teaching, and related activities for their cutting-edge and highly soughtafter academic programmes.

He stated that apart from establishing new programme, the University under his watch has continued to provide the necessary wherewithal, for all relevant centres and structures, mandate and support that would boost the research profile and standing of the University. He added that the support systems has propelled the activities of centres like the Centre for Undergraduate Research, the Centre for Training and Research, and Centre for Sponsored Project, which he noted was the centralised grant support and management outfit of the University.

He said "another research outfit that has brought recognition to the University is the Centre of Excellence for Sickle Cell Disease Research and Training that has produced ground breaking research in partnership with investigators from 23 clinical sites across the country and with institutions within and outside Africa".

The University, he said, is also noted as a leading centre for

cardiovascular research, heavy metal poisoning amongst others".

The Vice Chancellor stated that over the years, the University has attracted a quantum of TETFund, institution grants, national and international grants to the tune of over 1 billion Naira in research revenue in 2022 alone.

He concluded that the feat achieved in his administration in terms of academic and infrastructural development was made possible with the complete automation of administrative and academic processes as well as the zero tolerance of the Administration for corruption and other unbecoming acts, which has ensured the restoration of due process and best practices in the University.

# Sunderland Varsity Delegation Visits NUC

delegation from the University of Sunderland, United Kingdom (UK) led by its Associate Professor, Derek Watson, penultimate Wednesday, visited the Acting Executive Secretary, National Universities Commission (NUC) Mr. Chris J. Maiyaki, in his office.

In his remarks, the team leader, Professor Watson informed the Acting Executive Secretary that the University of Sunderland have nearly 6,000 international students, while it boasts of 37% total student population and 1,500 students, studying online from locations across the World.

She said that the University was ranked 9th in the UK for international (as voted for by students in what Uni student choice Awards 2019), reflecting the institutions leading credentials in transnational education (TNE) and distance learning and its significant expertise in how to both teach online and to ensure that our students have the best possible student experience.

She stated that with a community of 157,000 students around the world, the networking opportunities that studying with this global University provides were endless.

Professor Watson said that the purpose of their visit was to inform the Ag. Es of NUC that they intend to start Transnational Educational (TNE) and have already acquired a centre in Lagos in that regard.

She said that the teaching and learning method in Sunderland would be the same for students to before commencing full Programme.

Welcoming the team, the Acting Executive Secretary gave a vivid

be enrolled in Lagos, noting that the University was willing to ensure that students in Nigeria get good value for their money.

The team leader said the University would be teaching four courses at the Lagos centre that include: Computer Science, Network System Engineering, Business and Marketing Management as well as Business Management.

She informed the NUC management that the centre was a new creation, that was yet to be fully operational due to the fact that the University planned to get License of approval from NUC background of the evolution of the NUC, which began in 1962 as an Advisory body in the Cabinet Office before it became a statutory body in 1974.

He highlighted the functions of NUC to include: advising the President, State governors and private proprietors through the Minister of Education of the creation of a new university; laying down the Minimum Academic Standards for all universities in Nigeria and also accrediting their Programmes as well as ensuring that quality was maintained within the academic Programmes of the Nigerian Universities.

He informed the team that NUC remained the sole regulatory agency responsible for the orderly development of the NUS and had been executing for several decades.

He further told the University of Sunderland team that every year millions of students apply for admission into Nigerian Universities but only half of that population get admission. The Acting ES also said that NUC had developed other guidelines such as the development of guidelines for TNE Programme, a policy framework which must be strictly adhered to before starting

Mr. Maiyaki stated that the first generation universities came in the early 60s, followed by the second generation universities in the 70s, while more federal, state and private universities had been established with the country now boasting of 270 universities. He also disclosed that the Core Curriculum Minimum Academic Standard (CCMAS) document had just been consummated with the universities given the opportunity to develop 30% of their own quota in line with environmental peculiarities. any TNE in Nigeria.

He said the University of Sunderland must get a letter of approval from NUC before they could start TNE in Nigeria as the Commission was very particular about curriculum content, mode

of delivery and other issues which must be of international standard.

He advised the SU officials to write a letter of application to the Executive Secretary of NUC which would be forwarded to the TNE Committee for processing, thereafter, the committee would make recommendation to NUC Management before approval would be granted.

Mr. Maiyaki said that NUC was always willing to facilitate establishment of any mode TMA, if seekers of transnational education follow the right procedure.

# **French Embassy Team Pays Courtesy Call on Acting ES**

he Acting Executive Secretary, National Universities Commission (NUC), Chris J. Maiyaki, last Tuesday, received in audience a delegation from the French Embassy led by the Head of Cooperation and Culture Affairs/Director at the French Institute of Nigeria, Mr. Judikael Regnaut, in his office.

Receiving the delegation, Mr. Maiyaki gave a brief history of the establishment of the NUC, which began as an advisory agency within the Cabinet Office in 1962 and later evolved into a statutory agency by 1974, with a clear mandate to oversee the orderly development of university education in Nigeria. He further highlighted the functions of the Commission to include: establishing minimum academic standards accreditation of academic programs; monitoring universities; recognising State Universities, and providing

for all universities and degree-awarding institutions in Nigeria; approving courses and programmes; conducting guidelines for processing applications to establish private universities.

He explained that Nigerian

universities faced immense demographic pressure, with a population of over 200 million people and the challenges they encountered in meeting the educational needs of a rapidly growing population.

Mr. Maiyaki underscored the timeliness of the visit at a time when Nigeria was desirous of strengthening its ties with France and acknowledged the longstanding relationship enjoyed by NUC with the He emphasised that Nigeria's educational landscape required capacity building not only for academic professionals but also for administrative personnel, nonteaching staff, and students.

delegation on recent developments at the NUC such as the launch of the Core Curriculum and Minimum Academics Standards (CCMAS) and review of the NUC Guidelines on Transnational Education (TNE).

According to him, the essence of these guidelines was to facilitate foreign investment in Nigeria's higher education sector, through six competitive models outlined in the TNE policy, aimed at delivering high-quality and reliable higher education services. French Embassy.

He reiterated the Commission's readiness to expand its partnership with France for a mutually beneficial projects that would contribute to and enhance higher education in Nigeria.

Responding to issues raised by the team, the Acting Executive Secretary expressed profound appreciation to the French Embassy delegation for their continued effort to strengthen their ties with Nigeria. Mr. Maiyaki also underscored the pressing need for additional scholarships to support Nigerian students in their pursuit of higher education.

He used the forum to convey the NUC's keen interest in establishing partnerships with France in various areas that could further enhance and deepen their relationship, all with the overarching goal of elevating the standards of higher education in Nigeria.

Earlier, in his remarks, Mr.

Regnaut had expressed gratitude to the Acting Executive Secretary for the warm reception extended to the delegation.

He informed Mr. Maiyaki of the French Embassy's enthusiasm and strong desire to strengthen their relationship with Nigeria, particularly through education, with the aim of deepening educational cooperation by actively supporting the training of teachers in Nigeria and fostering networks through the French language.

Also in her remarks, the Cooperation Attaché for French Language, Ms. Magaly Losange gave a vivid detail about the French Embassy's recently launched two-year FSPI (Fund for Solidarity and Innovative Project).

The project, according to her, which could be promoted at the national or regional level, was designed to enhance the skills of French teachers, and elevate students' proficiency in the French language in Nigeria.

Ms. Losange highlighted the significant advantages of studying abroad, while underscoring its potential for young Nigerians, given the country's proximity to French-speaking neighbours.

She added that they were proposing to commence short educational programmes in Nigeria that would allow students to master and practice French language.

# Core Academy Learning Centre Seeks Collaboration on e-Learning

He cited some measures through which the Commission functioned effectively to include, laying down the minimum academic standards for academic programmes, embarking on resource verification visits as well as accreditation visits whenever the need arose, recommending and processing the establishment of private universities and aiding the Government to formulate and implement policies that ensured the development of the NUS.

He acknowledged that the Yearning for university education had not abated while the demand remained everincreasing, adding that the time had come for the reinvention and repositioning of university education due to the pivotal role it played in the success or otherwise of any society.

The Acting Executuve Secretary said that the teeming youth were still grappling with shortage of space in universities since less than half of their number could be absorbed to study in the country, which had forced them to seek access outside the shores of the country and even in the process fell victims of dubious people.

He however assured that NUC was doing all within its powers to bridge the gap between the demand and supply of quality university education for the Nigerian population.

The NUC Scribe reminded the Core Academy team that Universities enjoyed autonomy now and were at liberty to collaborate with any well-meaning individual or organisation intending to bring about positive change and development to the NUS.

He charged the relevant Directorates in the Commission to study the proposal from their guests and identify the merits, expected outcomes and the deliverables from the capacity building training programme proposed by them.

According to him, the capability statement was of essence to ensure there was value addition to the universities involved.

In her response, the Director, Business Development of the firm, Mrs. Adeyemi expressed her gratitude to the Acting Executive Secretary and his team for according them the opportunity to meet and listen to their request.

She said another function that Core Academy International Learning Centre did included working directly with MSMEs (Micro, Small and Medium Enterprises) to build their capacity on entrepreneurship and staff management.

She added that the visit was for familiarity and to seek collaboration with the NUC to work with universities in order to train lecturers and students in the use of e-learning platforms and also enable them have a seamless transfer of knowledge at all times.

She noted that the COVID 19 experience had brought to fore the serious lapses within the Nigerian universities bordering on availability of other channels of delivering lectures as the face-to- face medium became compromised.

According to the Director, ICT of the centre Mr. Kayode Stephen, the project would make a significant impact in the way academic knowledge was shared and received within university settings.

He added that a small physical office network where the students could learn virtually from anywhere and at anytime was very essential.

He stressed that the design of any learning centre would be peculiar to the needs of that institution since there were various learning platforms at their disposal.
