# FG Assures Nigerian Students of Easy Access to Education Loan Scheme

he Federal Government of Nigeria, last week Wednesday assured Nigerians that no indigent students would be denied the government education student loan scheme billed to be launched in the upcoming weeks.

The Presidency also said that the Government was making frantic efforts to avert the planned strike by the Academic Staff Union of Universities (ASSU).

Chief of Staff to the President, Rt. Hon. Femi Gbajabiamila, disclosed these when he received in his office, at the state House, a delegation of the National Association of Nigerian Students (NANS), led by its President, Comrade Lucky Emonefe.

Hon. Gbajabiamila called on Nigerian students to speak up against voices condemning the Students' Loan Funds policies, saying the scheme was to ensure that no student, irrespective of their birth circumstances, was deprived of quality education in Nigeria.

The Chief of Staff further assured the students that the government was ready to avert

directives, declared an end to the strike by the academic unions in universities and higher institutions. According to him, "there may be another looming


any looming industrial action by members of ASUU, explaining that government was currently addressing issues that concerned the union.

He added that President Tinubu, GCFR, had, through several

ASUU strike, and we are trying to address that, we are looking at issues that concern ASUU, the impending strike and i believe we should be able to avert that as you have said earlier.

"We can always do our best to

avert strikes such as this. Luckily, we have a President who is more than anybody determined that the days of strike are over and left behind. We are hoping to be able to avert the strikes", he added.

The Chief of Staff affirmed the determination of President Bola Tinubu towards the successful take-off of the scheme, adding that the program would be launched within the next few weeks.

According to him, "Mr President is determined that we see it through and see it through successfully. It was supposed to be launched in January but it is anything worth doing and it is worth doing well.

"We are hoping it will be launched in the next two to three weeks, we are trying to dot the I(s) and cross the T(s) before it is launched to ensure we have policies that cannot be faulted."

He added that the student loan scheme, when successfully launched, would become part of the legacies of the present administration.

Hon. Gbajabiamila solicited the

support of Nigerians to ensure that no indigent student, who was genuinely in need of the loan, was left behind. "Now we are going to need you in the success of this policy because, generally, it is a well-received policy but there may be one or two segments of the society for the reason some people in some quarters may be kicking against it, this policy is for the Nigerian students, it is to make sure that no student is left behind when it comes to education.

"It is to make sure people are not deprived of their education just because of circumstances of their birth that itself is unconstitutional. "Now that the child of indigent should not be deprived of what should be a right, not to make education a privilege but a right. "So when voices speak up against it we expect you to rise for support, this is something that you all support, embrace and work towards its success", he said.

The Chief of Staff also applauded youth representation on the Federal Executive

Council, saying the Government was working on the establishment of a Youth Advisory Council that would advise the President on youth matters and other injunctions towards youth development.

"You have among you two comrades standing in for you in the cabinet, We are muling the idea that has not come to fruition yet I hope it will come to fruition, we are working assiduously on the Youth Advisory council that will sit from time to time and advise the President on youth matters and other matters that are geared towards youth development. We are hopeful that will come to fruition soon." He concluded.

Earlier in his address, the NAN President, Comrade Lucky Emonefe, commended President Tinubu for the up-scale of the Education budget, students' loan scheme and other giant strides and achievements in the education sector, especially the tertiary education sub-sector.

He called on the Federal Government to put extra efforts to

# Only Foreign Students in Nigerian Varsities Pay Tuition Fees in Dollar- Ag. ES

he Acting Executive Secretary, National Universities Commission (NUC), Mr. Chris J. Maiyaki, has debunked claims in some quarters that some universities in the country were charging tuition fees in dollar, but rather insisted that in the spirit of internationalisation of university education all over the world, only foreigners studying in universities in the country pay tuition in dollar.

While speaking last Thursday at a Media Parley with Education Correspondents Association of Nigeria (ECAN) in Abuja, Mr. Maiyaki warned that the Commission would not condone such act from any university.

He explained that no law in the country permitted that tuition in schools should be collected in foreign currencies.

He said, "On the dollarisation of tuition fees in the said university, we have investigated it and the university is not charging fees in dollars. They only charge dollars

Reacting to allegation that NUC had compromised the standard of education, given the number of

to foreign students. So, I want the media to join hands with us to tell the public that no Nigerian university is allowed to charge fees in dollars."


private universities it was approving, the NUC boss explained that the Commission was assiduously working to ensure that majority of Nigerians have access



to quality higher education through the involvement of well meaning Nigerians who have capacity, capability and wherewithal to undertake such a onerous venture.

Reaffirming the commission's determination to giving Nigerians quality higher education, he vowed that would continue to approve more universities as long as they meet standards and demonstrated the capacity for sustainability.

He disclosed that the commission would issue licences to two universities by next week to add to the existing ones in the country,

saying the development would give room for access to tertiary education and stem the tide of Nigerians going outside the country to study.

The Acting Executive Secretary added: "Due to the huge gap in demand and supply of university education, the National Universities Commission will continue to give approval for the establishment of more universities."

Similarly, Mr. Maiyaki stated that the commission would as a matter of deliberate policy continue to

recommend the establishment of more public and private Universities in Nigeria as the current number cannot meet the demand and supply gap.

He affirmed that Nigeria with about 270 Universities would soon have an additional two coming on board next week as approval had been given.

He explained that each year, close to 2 million Candidates apply for admission into Nigerian Universities, however only between 500,000 to 700,000 candidates were admitted, a development which caused pain for the families of candidates, the candidates themselves, and the University leaders.

"Nigeria will continue to widen university access by approving more universities to meet its demands and supply of quality education.

"We have no choice but to as a matter of deliberate policy, undertake the massification of universities," he said.

He said comparatively, the USA which has 335 million population has over 1,000 Universities, just as Brazil and Indonesia with a lesser population than Nigeria have more Universities.

He said based on this analogy, Nigeria with over 200 million population would require more Universities.

He declared that "Nigeria is undersubscribed as we have less numbers of Universities compared to the UK, USA, and India,".

Mr. Maiyaki said to improve access to Universities and meet the competing needs of candidates, Nigeria has approved the Transnational Education (TNE), Guidelines which gave the foreign countries opportunities to participate in the establishment of high standard Universities in Nigeria.

"This TNE system will make our graduates globally competitive. it is on the tripods of teaching, learning, and research.

He said the action would stem the tide of Nigerians going out to seek foreign University education.

According to him, the agency was

He said the commission in addition to public-owned Open Universities, has approved four (4) new private open Universities for location in different parts of the country.

developed a Unit cost analysis of what it would take to train a student in Nigerian tertiary institutions, as part of ensuring the successful implementation of the student loan scheme, which would be launched next week.

"It is a guideline for public and private Universities in Nigeria as scholars begin to apply for the loan. They know how much it takes, for example, to train a medical doctor or an Engineer," he said.

He called on stakeholders to key into the recently released 2023/2024 Core Curriculum Minimum Academic Standard (CCMAS), as "it is a paradigm shift to make Nigerian Universities and its graduates globally competitive."

He said a reference database for all Professors in Nigeria had also been published and will aid local and international agencies to collaborate and partner with Nigerian institutions for more development.

He further appreciated the decision of government to remove tertiary institutions from the IPPIS payment platform and consider it a major success recorded by the Commission as it had given the universities more autonomy.

The Acting Executive Secretary said the commission had always stood against issues of Degree mills, and certificate racketeering, stressing that the committee set up to investigate the foreign university certificate racketeering would soon submit its report.

Despite the success stories, the NUC Executive Secretary said the Commission had faced challenges of incessant strikes by the Universitybased Unions which affected the smooth running of the academic calendar, adding that paucity of funds had also led to the slow pace of ICT deployment in tertiary institutions in Nigeria.

Mr. Maiyaki informed the media that despite the paucity of funds, the NUC had done well to live up to its

responsibilities of serving as a bridge to ensuring that quality was maintained and sustained in the system.

This was achieved by the recent review and finalisation of work on the curriculum of Nigerian universities by brining it in tune with global competitiveness, which was christened Core Curriculum Minimum Academic Standards (CCMAS).

One of the major highlight of the event was the presentation of an award for excellence by the ECAN to the NUC boss, which the body described as a recognition for a job well done.

The Chairman of ECAN, Mr. Chuks Ukwuatu said the recognition was based on key performance indicators set by the association which saw NUC excelling in the discharge of it's responsibilities.

Receiving the award, the Acting Executive Secretary said: "I dedicate this recognition to all the

staff of the NUC, beginning from the security man at the gate to the highest ranking person. We did it together. I appreciate ECAN for the recognition."

In a vote of thanks, the Deputy Executive Secretary, Academics (NUC), Dr. Noel Biodun Saliu expressed appreciation to the ECAN for being part of the NUC family and for always responding to even short notice whenever called upon by the Commission.

He also thanked them for timely and objective reportage of events of the Commission and for seeking clarification on issues before rushing to the press and prayed that the symbiotic relationship would be sustained into the future.

He also appreciated all the NUC directors who supported the Executive Secretary in moving the Commission forward.

### RE: ABOUT 100 FAKE PROFESSORS JUST UNCOVERED IN NIGERIAN UNIVERSITIES – NUC **A REBUTTAL**

The attention of the National Universities Commission (NUC) has been drawn to news items, circulating on the social media, some national dailies and television stations, to the effect that the Commission has just "discovered over 100 fake Professors in Nigerian Universities". The NUC wishes to deny these media reports categorically and unequivocally. They are fake, untrue and a figment of the imagination of the author(s), all happening at an unsuitable time, when the nation is awaiting the outcome of the investigation into the fake certificate saga from universities in some neighbouring countries. The Commission therefore finds this development as unfair to all stakeholders.

Specifically, the fake news items have been circulating in two forms – (i) as a link to a 2019 online news item; and (ii) as a separate list of names of the alleged fake Professors in various Nigerian Universities, which was not the case. We consider these unfounded publications as ill-conceived and a ploy by unscrupulous persons to create in plausible a tone, disquiet, panic and provoking outcries at both the national and international levels.

For the avoidance of doubt, the Commission can confirm that it initiated in 2019 a laudable project, with the intent of compiling and publishing a list of full Professors in the Nigerian Universities System (NUS) through the use of an online portal to collate the requisite data. During the exercise, the NUC found anomalies, such as Associate Professors being listed as full Professors. It is essential to also state clearly that the Commission as a responsible Federal Government Agency, does not engage in half-baked exercises capable of tarnishing the image of Nigeria and the NUS. That was why the Commission deemed it necessary to share the collated data with the Nigerian Universities for the purpose of authentication by the competent authourities as to who qualifies to be a full professor. Based on the verified data, the Commission then in a landmark accomplishment, first published the list of full Professors who participated in the exercise in 2019. It was understood that this would be succeeded by a continuous process of updating the list of full Professors. It is important to state at this point that all the issues pertaining to the 2019 verification of full Professors in Nigerian Universities were concluded in 2019. Since then, the Commission has entrenched a more reliable system of generating the list of full Professors in the NUS. The Commission is also conscious of the fact that some of the academics not captured in the 2019 exercise may now have matured and progressed to become full Professors; this being the reason why it continuously updates the list of full Professors in the NUS.

The National Universities Commission questions the rationale behind recycling this stale 2019 news of an activity it initiated, conducted and laid to rest in the same year. The purpose and objective of resurrecting in 2024 (more than 4 years later) this-nolonger-fresh news, is clearly intended to generate unnecessary controversy at an unsuitable time, whilst lacing it with a false list of fake Professors.

The National Universities Commission owes it a solemn duty to protect and guard the integrity of the many hardworking and committed academics in the NUS, who have earned national and international respect and recognition. Therefore, the Commission has been saddled with the vital and strategic responsibility by its enabling laws, to uphold the sanctity of quality in all aspects of our University Education delivery.

The Commission wishes to use this medium to advise Government officials at all levels, members of the NUS, the international community, and the public, to please disregard these items of fake and stale news which have long been laid to rest in 2019. ### Press Release SUSPENSION OF EVALUATION AND ACCREDITATION OF DEGREE CERTIFICATES FROM THE BENIN AND TOGO REPUBLICS.

The attention of the Federal Ministry of Education has been drawn to the commendable work of investigative journalism that led to the publication by the Daily Nigerian Newspaper dated 30th December 2023 titled "UNDERCOVER: How DAILY NIGERIAN reporter bagged Cotonou varsity degree in 6 weeks, participated in NYSC scheme". This was also carried in various social media.

- 2. This report lends credence to suspicions that some Nigerians deploy nefarious means and unconscionable methods to get a Degree with the end objective of getting graduate job opportunities for which they are not qualified.
- The Federal Ministry of Education vehemently decries such acts and with effect from 2<sup>nd</sup> January 2024 is suspending evaluation and accreditation of degree certificates from Benin and Togo Republics pending the outcome of an investigation that would involve the Ministry of Foreign Affairs of Nigeria and the two countries, the ministries responsible for Education in the two countries as well the Department of State Security Services (DSSS), and the National Youths Service Corps (NYSC). The Ministry therefore wish to call on the General Public to support its efforts, show understanding and provide useful information that will assist the Committee in finding lasting solutions in order to prevent further occurrence.
- The Ministry has also commenced internal administrative processes to determine the culpability or otherwise of her staff for which applicable Public Service Rules would be applied.

- The issue of degree mills institutions, i.e institutions that exist on 5. paper or operate in clandestine manner outside the control of regulators is a global problem that all countries grapple with. FME has been contending with the problem including illegal institutions located abroad or at home preying on unsuspecting, innocent Nigerians and some desperate Nigerians who deliberately patronize such outlets. Periodically, warnings have been issued by the Ministry and NUC against the resort to such institutions and in some instances, reports made to security agencies to clamp down on the perpetrators. The ministry will continue to review its strategy to plug any loopholes, processes and procedures and deal decisively with any conniving officials.
- The Ministry had always adopted the global standard for evaluation 6. and accreditation of certificates of all forms which relies on receipt of the list of accredited courses and schools in all countries of the World.
- The Ministry wishes to assure Nigerians and the general public that, it is already putting in place mechanisms to sanitise the education sector, 7. including dissuading the quest for degree certificates (locally or from foreign countries) through a re-invigorated focus on inclusivity: reliance on all skill sets as directed by President Bola Ahmed Tinubu GCFR.
- The Federal Ministry of Education is committed to collaborating with stakeholders, including civil society organizations, to consistently enhance the Nigerian education system and we value the public's understanding and patience as we strive to address these issues.
- The Federal Ministry of Education wishes all Nigerians a happy new 9. year. A year in which we would all work together to strengthen our education sector.
