FG Approves Over 600 Billion for Projects in Higher Institutions – Echono

The Federal Government has approved the sum of 683 billion as direct disbursement for special projects in the higher institutions of learning across the country. This was made known by the Executive Secretary of the Tertiary Education Trust Fund (TETfund), Arc. Sonny Echono during the Annual Strategic Planning Meeting of TETfund with beneficiary institutions held on Friday 12th January, 2024 at the TETfund auditorium in Abuja.

Arc. Echono told the heads of the beneficiary institutions that President Bola Ahmed Tinubu, GCFR, had approved the Year 2024 disbursement guidelines in the total sum of N683,429,268, 402.64, saying that from this total, 90.75 % was budgeted for direct disbursement and 8.94 % for some designated special projects.

He stated that a stabilization of 2.27 % was allowed to enable the Fund respond to emerging issues, adding that the estimate was inclusive of the difference between

actual collections and the projections made for November and December 2023 collections, as requested and approved by Mr. President. direct disbursement and N250million as zonal intervention.

He added that each Polytechnic

Based on this approval, he said that each University shall get, for the year 2024 intervention cycle, t h e t o t a l s u m o f N1,906,944,930.00, noting that t h i s c o m p r i s e d N1,656,944,930.00 as annual in this edition shall get N1,165,355,235.00, comprising of N1,015,355,235.00 as annual direct disbursement and N150million as zonal intervention.

Acting ES Receives Pro-Chancellor Skyline University

The TETfund Executive Secretary explained further that it was pertinent to note that the estimate represented a very significant increase above the last year's intervention and indeed every other year, since inception. This remarkable success, he said, was due to sustained efforts at expanding and increasing the efficiency of collection of the Education Tax, and the gracious concurrence of Mr. President for an increase in the tax from 2.5% to 3.0% in the year 2023.



Tahir Mamman (SAN), Minister of Finance and coordinating Minister for the Economy, the Chairmen and members of the Senate and House Committees on TETFund and the Chairman, Federal Inland Revenue Services (FIRS) for their unwavering support, towards the sustainably improvement of the collection.

He recalled that at the year 2023

strategic meeting and indeed other workshops organized in the course of the year, pertinent issues and concerns were raised by the stakeholders, necessitating a refocus and provision of some new areas of intervention for the year 2024.

The approved new intervention, reiterated, was in line with the Annual Direct Disbursement, including the establishment of Career Centers/Unit, in all categories of beneficiary institutions, as well as the Institution Based Skills development for Polytechnics. He added that, in response to popular demands from the Colleges of Education, the teaching practice allocation had been greatly enhanced.

For the Special Direct Disbursements, Arc. Echono stated that TETfund had increased the allocation for the Special High Impact Programme (SHIP), and the number of benefitting institutions had also been increased to two per geopolitical zone, per category, giving a total of 36 beneficiary institutions. He listed other areas of Special Direct Disbursement to include; provision for Hostels, using the Public/Private Partnership arrangement, innovation hubs, Disaster Recovery, Security Infrastructure, and Completion of abandoned projects, among many others.

In a bid to resolve the problems arising from the increase in exchange rates to the benefitting scholars, Arc. Echono said that TETfund had made provisions in the year 2024 intervention to address the shortfall therein, stressing that it had also sustained allocations for research, including the National Research Fund, Research and Innovation Fund, Uptake of research findings to commercialization and supervision of scholars for PHD research.

He added that the Fund had also made provisions for four central multipurpose laboratories and additional provision for the three agricultural laboratories and demonstration farms initiated in 2023.

Arc. Echono reiterated that TETfund was determined to deepen research, promote innovation and honing of skills in

the beneficiary institutions, saying that it would also encourage the discovery and development of creative talents amongst scholars and especially students, as a major pillar of the renewed hope agenda of the present administration. He added that the Fund had sustained the implementation of the ICT road map with the provision for converged services, subscription services for electronic journals and databases, internet access and the Tertiary Education Research and Application Services Platform (TERAS) initiative.

Whilst increasing the ICT Support Intervention to beneficiary institutions as part of TETfund ICT initiatives this year, the Fund sought to deliver online access to a one-stop aggregation of online learning and course certifications from the world's leading providers: Udemy, Udacity and Coursera using AVIS which is an aggregated multi-provider online course learning and certification platform. This, he said, was an initiative by the Fund to sponsor beneficiary institutions students' access on the course learning/certification platform.

The Executive Secretary assured the participants that the Fund would intensify efforts at automating its processes and to this effect; it was commencing the parallel run for electronic submissions of the Physical Infrastructure Intervention submissions from January 22, 2024. He said that the Fund would equally be expanding access for the diverse student population of the National Open University, by upgrading their study centers to experience centers to facilitate improved access to teaching, learning and research.

Arc. Echono explained further that there would be an upgrade of laboratories, workshops and equipment to Universities, Polytechnics and Colleges of Education (Technical) in the year 2024 intervention. To this end, he noted that the Fund had empanelled Teams to visit institutions, access their priority needs and make recommendations based on qualitative selection criteria, adding that provision had also been made for the early grade resources centers phase II to Colleges of Education.

He told the heads of institutions that the year 2024, just like the previous year 2023 remained a promising year that had seen tremendous improvement in the collection of education taxes. saying that as the TETfund distributed the year 2024 allocation letters at the meeting, he said that the Fund had kept its promise to constantly improve its operations and reduce processing time. He added that the Fund shall also uphold merit and comparative advantage in citing of critical national infrastructure.

The outgone year 2023, he recalled, was an impactful year that witnessed series of programmes such as the development of the TETFund ICT

roadmap culminating in the deployment of the Beneficiary Identity Management System (BIMS) and launching of the Tertiary Education, Research, Applications & Services (TERAS) platforms. He urged the benefiting institutions to utilize the opportunity to discuss some of the issues affecting their institutions and the Fund's interventions or operations.

Arc. Echono called on all heads of institutions present at the meeting to ensure the smooth, timely, judicious, and effective implementation and utilization of the year 2024 intervention allocation, to make the muchneeded impact in their respective tertiary institutions.

He advised them that, in addition to the broad based budget and project monitoring committee stated in their letter of allocation, they should consult widely with the community in the implementation of their TETFund projects, saying that heads of institutions should ensure timely payments to contractors and vendors when due, as this would enable the proper completion of projects and mitigate the incidence of contractor writing letters of complaints to the Fund.

He used the opportunity to register profound gratitude to President Bola Ahmed Tinubu, GCFR, for his commitment to the development of Education in his Renewed Hope agenda and to Prof. Tahir Mamman (SAN), for his leadership, trust and prompt consideration of TETfund's requests, saying that the Education sector shall remain eternally grateful for his eager, dedicated and selfless service as Minister of Education.

He also expressed appreciation to the Heads of regulatory agencies, the National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE), for their sustained support and indeed to all the staff of the Fund for keeping faith with its reform measures.

He expressed hope that sustained improvements in performance across all sectors and by all actors in the education family would deliver a robust and functioning system which shall be an enduring legacy of the present Administration.

In his goodwill message, the Ag. ES, NUC, Mr. C. J .Maiyaki thanked the Federal Government for its huge intervention in the university education in particular, and the higher education in general.

He urged the heads of the beneficiary institutions to judiciously utilise the allocations and disbursement in the best interest of the Nigerian University Systen (NUS) and the country at large.

The Executive Secretary was accompanied by the Head, Special Projects Dr. Abubakar Tanko and other supporting Staff.

He stated that since the Commission could not have a critical mass of manpower in the medical field, it was mandatory for it to liaise with the right partners, such as the Medical College, to achieve that mandate.

He said the CCMAS had been activated and in full use by the Universities. By virtue of its dynamic nature, another review would be considered soon in order for the Commission to made the NUC make policies that would continue to encourage good spirited individuals and corporate organizations to establish standard private universities. The effort would help bridge the gap between demand and supply of quality university education in the country.

Mr. Maiyaki also intimated his guests on the Commission's introduction of its guidelines for transnational education (TNE) that would help to expand access through foreign involvement guided by six competitive models which, he said, was a response to the call for reform in the

education sector.

He argued that the world had become quite unstable as a result of Covid 19 and there was also the unbalanced ratio of doctor to patient in the access to quality healthcare delivery as well as medical tourism described as brain drain.

He however, emphasised the need to use the smart brains in the Universities to solve the problems bedeviling the nation's existence.

According to him, aspects such as curriculum, remuneration, equipment, infrastructure and political will to do the right thing at the right time, could form the bases of some quality research that could provide the country with some level of sufficiency.

He said the Commission could not hold any exclusive reserve in respect to the effective and efficient implementation of the new transnational education guidelines.

He, therefore, called on the College to consider it a duty to approach the Commission on any constructive input in respect to the guidelines.

Earlier, in his remarks, the President of the College, Doctor Ebeigbe thanked the Acting Executive Secretary for his warm reception and said the main

that the NUC remained the foremost regulatory body for all universities in Nigeria and was saddled with the responsibility to ensure the orderly development of universities across the country, lay down minimum academic standards, grant approval for the take-off of new academic programmes as well as accredit all degree programmes and ensure quality was guaranteed in the system. proprietor of the proposed University, Dr. Akanji Mustapha Abdul Aziz, who spoke with the Executive Secretary in French Language, thanked him and the NUC management for the warm reception accorded the delegation and lauded the Commission for its efficient and effective supervision of the university system in Nigeria.

He further noted that the vision for the proposed Akanji Aladikun University was

Acting ES Receives Pro-Chancellor Skyline University

The Acting Executive Secretary, National Universities Commission (NUC), Mr. Chris J. Maiyaki, last Wednesday received the Pro-Chancellor of Skyline University, Kano, Mr. Nitin Anand, in his office. The singular act prompted the Minister of Education to set up a committee that would look into the matter with a view to preventing future occurrences and prosecuting the erring institutions. advantage of any legal system and always trying to perfect their nefarious activities.

He said in 2019, the Commission saw the need to put together a compendium of full-fledged professors of the Nigerian

In his welcome remarks, the NUC Scribe commended the utmost commitment the Pro-Chancellor had shown overtime in ensuring that the Commission played its pivotal role of ensuring the smooth running of the University.

He said a visit of such nature always add value to both the Commission and the University because it was an avenue to share information and feel the pulse of that university which could possibly help to nip certain issues in the bud before they go out of hand.

He decried the recent fake certificate saga that had attempted to dent the sterling image of the Nigerian University System (NUS). The Acting Executive Secretary said it was a wake up call for everyone to be very careful not to fall a victim of the miscreants.

He added that the Commission had never rested on its oars in going after illegal degree mills that were looking for innocent Nigerians to prey on, due to limited access to quality university education.

He, however, urged universities not to allow this isolated case to becloud the rich academic trajectory and reputation that had been enjoyed over the years. He noted that it was a global menace that needed to be handled with seriousness. There were miscreants always waiting to take University System. It was done to make easy identification and access, as well as to separate the wheat from the chaff.

Unfortunately, he said some media houses wrongly published random names of people and tagged them fake professors, tainting the image of even the hardworking professors in the NUS.

Mr. Maiyaki informed his visitor that the Commission had sent out a very powerful rebuttal because of the gravity of the fake publication.

He also said a directive had been issued by the Commission on the full implementation of the new Core Curriculum Minimum Academic Standards (CCMAS) by

Universities.

He said due to the dynamic nature of the document, full implementation must be done assiduously since any delay might cause it to be ineffective for the system.

He further said the Commission had launched the guidelines for transnational education (TNE) to provide more access to quality University education and improve the frontiers of knowledge to include other universities from outside the country. university had enjoyed from the Commission.

He said the sole mandate during the establishment of skyline university was to have an institution of international repute without compromising quality in any aspect, but due to the location of the institution, it was a challenge securing a great number of quality academics.

This, he said had made the university to maintain a 75/25% ratio of full time and part time academics, with most of the

He attested to the good quality of graduates the university was able to produce and the number of female students' enrolment especially considering the society where the university was located which did not encourage university education for girls but prioritized marriage after high schools.

He added that state of the art IT infrastructure had been installed which would give the students the best experience they could get anywhere in the world.

He said upholding the tenets of

The guidelines, he said, was backed by six competitive models of delivery which would ensure accurate and effective delivery of knowledge and that only credit worthy universities would be provided with the opportunity to contribute to this course.

Responding, the Pro-Chancellor, Skyline University Mr. Nitin Anand expressed gratitude for the audience given to him and also the invaluable guidance and support his visiting coming in from outside the country.

He explained further that it was an aspiration for the university to keep raising its bar from time to time and was presently seeking to be a member of the (ASCSP) the School of Business, other international memberships and especially seek international accreditation, which would earn it an international reputation. teaching and ensuring only students that had met the bar successfully were graduated by the University.

He alluded to ensuring that every Skyliner was armed with entrepreneurship skills to help them navigate their life after graduation, he said having publications was highly encouraged by the University and it therefore financed all university publications from start to finish.

RE: ABOUT 100 FAKE PROFESSORS JUST UNCOVERED IN NIGERIAN UNIVERSITIES – NUC A REBUTTAL

The attention of the National Universities Commission (NUC) has been drawn to news items, circulating on the social media, some national dailies and television stations, to the effect that the Commission has just "discovered over 100 fake Professors in Nigerian Universities". The NUC wishes to deny these media reports categorically and unequivocally. They are fake, untrue and a figment of the imagination of the author(s), all happening at an unsuitable time, when the nation is awaiting the outcome of the investigation into the fake certificate saga from universities in some neighbouring countries. The Commission therefore finds this development as unfair to all stakeholders.

Specifically, the fake news items have been circulating in two forms – (i) as a link to a 2019 online news item; and (ii) as a separate list of names of the alleged fake Professors in various Nigerian Universities, which was not the case. We consider these unfounded publications as ill-conceived and a ploy by unscrupulous persons to create in plausible a tone, disquiet, panic and provoking outcries at both the national and international levels.

For the avoidance of doubt, the Commission can confirm that it initiated in 2019 a laudable project, with the intent of compiling and publishing a list of full Professors in the Nigerian Universities System (NUS) through the use of an online portal to collate the requisite data. During the exercise, the NUC found anomalies, such as Associate Professors being listed as full Professors. It is essential to also state clearly that the Commission as a responsible Federal Government Agency, does not engage in half-baked exercises capable of tarnishing the image of Nigeria and the NUS. That was why the Commission deemed it necessary to share the collated data with the Nigerian Universities for the purpose of authentication by the competent authourities as to who qualifies to be a full professor. Based on the verified data, the Commission then in a landmark accomplishment, first published the list of full Professors who participated in the exercise in 2019. It was understood that this

would be succeeded by a continuous process of updating the list of full Professors. It is important to state at this point that all the issues pertaining to the 2019 verification of full Professors in Nigerian Universities were concluded in 2019. Since then, the Commission has entrenched a more reliable system of generating the list of full Professors in the NUS. The Commission is also conscious of the fact that some of the academics not captured in the 2019 exercise may now have matured and progressed to become full Professors; this being the reason why it continuously updates the list of full Professors in the NUS.

The National Universities Commission questions the rationale behind recycling this stale 2019 news of an activity it initiated, conducted and laid to rest in the same year. The purpose and objective of resurrecting in 2024 (more than 4 years later) this-no-longer-fresh news, is clearly intended to generate unnecessary controversy at an unsuitable time, whilst lacing it with a false list of fake Professors.

The National Universities Commission owes it a solemn duty to protect and guard the integrity of the many hardworking and committed academics in the NUS, who have earned national and international respect and recognition. Therefore, the Commission has been saddled with the vital and strategic responsibility by its enabling laws, to uphold the sanctity of quality in all aspects of our University Education delivery.

The Commission wishes to use this medium to advise Government officials at all levels, members of the NUS, the international community, and the public, to please disregard these items of fake and stale news which have long been laid to rest in 2019. Press Release <u>SUSPENSION OF EVALUATION AND ACCREDITATION OF</u> <u>DEGREE CERTIFICATES FROM THE BENIN AND TOGO</u> <u>REPUBLICS.</u>

The attention of the Federal Ministry of Education has been drawn to the commendable work of investigative journalism that led to the publication by the Daily Nigerian Newspaper dated 30th December 2023 titled "UNDERCOVER: How DAILY NIGERIAN reporter bagged Cotonou varsity degree in 6 weeks, participated in NYSC scheme". This was also carried in various social media.

 This report lends credence to suspicions that some Nigerians deploy nefarious means and unconscionable methods to get a Degree with the end objective of getting graduate job opportunities for which they are not qualified.

3. The Federal Ministry of Education vehemently decries such acts and with effect from 2nd January 2024 is suspending evaluation and accreditation of degree certificates from Benin and Togo Republics pending the outcome of an investigation that would involve the Ministry of Foreign Affairs of Nigeria and the two countries, the ministries responsible for Education in the two countries as well the Department of State Security Services (DSSS), and the National Youths Service Corps (NYSC). The Ministry therefore wish to call on the General Public to support its efforts, show understanding and provide useful information that will assist the Committee in finding lasting solutions in order to prevent further occurrence.

 The Ministry has also commenced internal administrative processes to determine the culpability or otherwise of her staff for which applicable Public Service Rules would be applied. 5. The issue of degree mills institutions, i.e institutions that exist on paper or operate in dandestine manner outside the control of regulators is a global problem that all countries grapple with. FME has been contending with the problem including illegal institutions located abroad or at home preying on unsuspecting, innocent Nigerians and some desperate Nigerians who deliberately patronize such outlets. Periodically, warnings have been issued by the Ministry and NUC against the resort to such institutions and in some instances, reports made to security agencies to clamp down on the perpetrators. The ministry will continue to review its strategy to plug any loopholes, processes and procedures and deal decisively with any conniving officials.

6. The Ministry had always adopted the global standard for evaluation and accreditation of certificates of all forms which relies on receipt of the list of accredited courses and schools in all countries of the World.

7. The Ministry wishes to assure Nigerians and the general public that, it is already putting in place mechanisms to sanitise the education sector, including dissuading the quest for degree certificates (locally or from foreign countries) through a re-invigorated focus on inclusivity: reliance on all skill sets as directed by President Bola Ahmed Tinubu GCFR.

8. The Federal Ministry of Education is committed to collaborating with stakeholders, including civil society organizations, to consistently enhance the Nigerian education system and we value the public's understanding and patience as we strive to address these issues.

9. The Federal Ministry of Education wishes all Nigerians a happy new year. A year in which we would all work together to strengthen our education sector.
