said that the Commission was poised to ensure full implementation of the recently launched Core Curriculum Minimum Academic Standards (CCMAS) by all universities in Nigeria.

He said this last Tuesday, when the Commission played host to the seek recognition and partnership in the implementation of its programmes.

Mr. Maiyaki stated that Registrars were the nexus of university academic and administrative activities, adding that they were also the drivers of policies in the system. CCMAS as the document was now a reference document for NUC Resource Verification going forward.

He stressed that the CCMAS was painstakingly put together by seasoned professors from each programme, professionals and captains of industries, adding that

the outcome of the CCMAS was in line with global best practices, fitfor-purpose and capable of producing graduates that could compete globally.

The Acting Executive Secretary, noted that the visit was coming at a time when the Commission was repositioning the Nigerian Universities System (NUS), adding that the Commission had recently launched a new guideline for cross boarder education to bridge the gap between demand and supply.

"The idea behind the cross boarder education guideline is to open up our education space for international partnership and collaborations while creating an enabling environment to expand access to university education", he said.

Mr. Maiyaki noted that plans were on ground to re-launch and review the manual for universities ceremonies. The manual, he said, would ensure uniformity in the way university ceremonies were been conducted.

In his words: "We will ensure that as soon as the draft manual is ready, a copy will be sent to your association for your input.

"You should know that we take your role as Registrars seriously, as you are the institutional memory of your respective universities," he stated.

He urged the ARNU leadership to send a communiqué to the Commission on resolutions made by the Association during its recently held annual workshop at the National Open University of Nigeria (NOUN), Abuja, assuring that the NUC was ready to partner with ARNU for a better university system.

Responding, the ARNU Chairman, Mr. Ife Oluwole, fnim, fcia, stated that the Association operated as one unified body, adding that the office of a Registrar was a position recognised by the law establishing Nigerian universities as the Chief Administrative Officers, exofficio secretaries to Council, Senate, Congregation and

Convocation and the Chief Advisers to these bodies.

He added that Registrars were responsible for all records both academic and administrative pertaining to staff.

The Registry, under the Registrars leadership, served as the gateway for students entering and exiting the University. The Registrar interfaced with students before, during, and after their studentship.

He said "we are the gate-keepers and touch-bearers of the NUS. We are the record keepers and policy executors of the Nigerian universities.

"Sitting with you in your office today are men and women who are dedicated to seeing Nigerian University System compete on the global stage".

Mr. Oluwole stated that the Manual of university administration published by the NUC some years back spoke much about the pivotal roles of Registrars within the NUS.

He, therefore, called on the Commission to carry the Registrars along in formulating policies as it affected the universities and also when providing training for Principal Officers of universities, urging that the Commission should actively commit to involving Registrars as they were critical stake-holders in university education.

The ARNU Chairman called on the leadership of the NUC to consider the re-introduction of institutional accreditation alongside programme accreditation, adding that it would, no doubt, address gaps in the NUS and enhance quality in other spheres of universities.

He noted that ARNU over the years hold training for its members so that they could greatly impact on the entire system, stating that the Association during its Business meeting held twice a year normally holds workshop in April and its Retreat in October.

The Chairman extended to the Acting Executive Secretary an invitation to deliver a keynote address at the second edition of its workshop to be held at the National Open University of Nigeria NOUN and assured that the ARNU was committed to assisting the Commission in achieving it goals.

Acting ES Receives ABNU Delegation

he Acting Executive Secretary, National Universities Commission (NUC), Mr. Chris J. Maiyaki, last Tuesday received in audience the leadership of the Association of Bursars of Nigerian Universities (ABNU), led by the President, in his office led by the President Mrs. Hadiza Goje.

They came to engage the Commission on discussions concerning recent government circulars and policies on financial administration in Nigerian Universities.

Welcoming the team, the Acting Executive Secretary acknowledged the commendable efforts of ABNU over the years in serving the Nigerian University System (NUS), highlighting their invaluable contributions.

He underscored the collaborative efforts between ABNU and NUC, particularly in facilitating overseas training opportunities for bursars.

He emphasised the pivotal role of bursars in resource management within universities and also pointed out the

at further increasing access to university education.

meticulous selection process involved in entrusting them with such responsibilities.

Mr. Maiyaki told the delegation that their visit to the NUC coincided with a period of significant expansion of the Commission's activities aimed

Universities as at date, comprising 62 Federal, 63 States and 149 Private universities.

He explained that Nigeria currently faced significant problem of access as universities available could hardly cater for the demand for higher education.

The NUC scribe also lamented that the system witnessed an annual enrolment of over 2 million prospective individuals seeking university admission with the existing institutions only able to accommodate between 550,000 to 750,000 students.

Stressing on the need to address this gap, he reiterated that the NUC remained unwavering in its commitment towards facilitating the establishment of additional universities across Nigeria.

This strategic initiative, he said, was aimed at bolstering accessibility and meeting the escalating demands for tertiary education and drew attention of his visitors to the fact that despite the presence of 149 Private universities, they could only cater for approximately 10 percent of the Nigerian university candidates seeking for education.

Mr. Maiyaki added that the developmental trajectory of these private institutions also required granting them time to mature and expand their capacity in order to effectively contribute to the educational landscape.

On the recent achievements of NUC, he highlighted the launch of the Core Curriculum Minimum Academic Standards (CCMAS) which was a collaborative effort involving academia and industry stakeholders.

He recounted that the process commenced in 2018 and was finally launched in 2023, highlighting the importance of the curriculum in shaping the educational landscape.

On the roles of the Commission in the NUS, the Acting ES

mentioned them to include: setting Minimum Academic Standards, conduct of accreditation to academic programmes, Resource Verification for new programmes, Inspection and Monitoring of universities, formulating policies, and processing the licensing of the establishment of private universities.

He informed the meeting that the NUC had recently introduced guidelines on Transnational Education (TNE), encompassing six competitive models.

This initiative, he stated, allowed foreign nationals to actively participate in university education in Nigeria and extended his well wishes to the ABNU executives and wished them harmony.

Responding to some issues, the Acting ES commended the association for raising fundamental issues, particularly those regarding the oversight undertaken by the National Assembly, acknowledging the current practice was not costeffective.

He assured ABNU that the Commission would carefully consider the matter and advocate strongly on behalf of the universities.

He also informed the delegation that the Honourable Minister of Education had issued a letter to universities on Post- IPPIS procedure and encouraged Bursars to thoroughly study the document and provide recommendations to facilitate its implementation.

He tasked ABNU to review the provisions of the new circular, engage in discussions, and offer constructive observations for further consideration.

He added that Duty Tour

Allowance (DTA) for Principal Officers of Universities was clearly outlined in extant government circulars, including those of Bursars as Principal Officers of the University.

He clarified that the Governing Council could not determine DTA for Principal Officers, as there were established guidelines for their operation and advised ABNU to officially communicate the issues to the NUC in writing to enable the Commission, escalate the issue to the appropriate authority for attention and necessary action.

On overseas training for bursars, the Acting Executive Secretary mentioned that the NUC had previously secured waivers to facilitate such endeavours, noting that despite recent circulars imposing restrictions on travel, these exceptions could still be made for the NUS.

He, however, stressed the imperative for universities to comply strictly with government directives and circulars.

The ABNU Chairperson, Mrs. Hadiza Goje, conveyed the Association's appreciation to the NUC Management for the opportunity to discuss issues concerning financial administration in Nigerian universities.

She highlighted the pivotal role of bursars as financial stewards within Nigeria's academic institutions as Bursars were tasked with exploring avenues to generate funds for the seamless operation of universities and serve as advisers to the Vice-Chancellor on financial matters. ensuring adherence to financial regulations.

She said the Association represented a unified entity comprising both federal, state, and private universities.

Mrs Goje used the opportunity to express the concern of ABNU over the frequent summons and visits to the National Assembly

upon request, lamenting that these actions significantly disrupt the Bursar's ability to fulfil their core responsibilities due to their excessive frequency in Abuja.

She appealed to the NUC to address this issue, advocating for a system where bursars might be summoned only on critical matters, suggesting that some of them could be handled electronically or alternatively via a representative in lieu of their always physical presence.

She also spoke on the issue of the Integrated Payroll and Personnel Information System (IPPIS), noting that as of last month, university staff were still being paid through IPPIS, despite the government's proclamation exempting universities from the scheme.

The Chairperson also presented the matter of Duty Tour Allowance (DTA) for Bursars,

highlighting the lack of uniformity in its application among universities, pointing out that Bursars were not on CONTISS 15, hence there was no provision for them under the current structure.

She mentioned that in many universities, the DTA for Principal Officers were determined by the University Governing Council, noting that this practice led to inconsistencies in allowance payment and also sought clarification on the furniture allowance paid to Vice-Chancellors upon assuming office.

At the end of deliberations, the meeting resolved that upon receiving letters detailing areas of interventions, NUC would write a cover letter forwarding recent government Circulars to universities for information and implementation.

The NUC also pledged to seek further clarification on the DTA for university's Principal Officers from the Office of the Head of Service of Government of the Federation.

JAMB Releases 2024 UTME Results, 64,624 **Results under Investigation**

he Joint Admissions and Matriculation Board (JAMB), has released the results of candidates who participated in the 2024 Unified Tertiary Matriculation Examination (UTME) with 64.624 results under investigation.

The Registrar/ Chief Executive Officer of JAMB, Professor Ishaq Oloyede, disclosed this at a news conference in Bwari this Monday.

Professor Oloyede said that 1,989,668 candidates registered for the examinations held in 118 towns in 774 Computer Based Test Centres (CBT).

According to the Registrar, out of the registered candidates, 1,904,109 sat for the examination, while 80,810 were absent.

He explained that 64,624 results were under investigations for various reasons, such as verification (2,896), procedural investigations (4,594), and prima facie established exam misconduct (78).

Professor Oloyede said other results under investigation were centre-based investigation involving 57,056 candidates in 18 centres across the country.

The 18 centres listed for investigation were 12 in Edo, three in Akwa Ibom, two in Delta and one in Kwara State.

"The Board witnessed a nearzero infraction situation in the 2024 UTME except for a few cases, which represent just a tiny fraction of what was reported last year.

"This is encouraging and the Board is poised to consolidate on the successes recorded," he said.

While giving analysis of the results, the Registrar said 8,401 candidates representing 0.5 percent scored 300 and above, while 77,070 candidates candidates representing 24 percent scored 200 and above, and 1,402,490 representing 76 percent scored below 200.

"A total of 1,989,668 candidates registered for the examination, 24.7 percent higher than the figure for the year 2023.

"Of the 1,989,668 registered, 1,904,189 were present and verified, 2,899 were present but unverified, 80,810 were absent.

"There is a significant improvement in the enrolment of females, with over one million girls registering for the examination.

"This is the first time in three years that the number of females will be more than that of their male counterparts.

"Out of the total registration, 3,164 were of persons living with disabilities (PLWD). There is a 36.2 percent increase in the enrolment of PLWDs as compared to last year.

"The Board is today releasing the results of 1, 842, 464 candidates. Sixty four thousand, six hundred and twenty four results are under investigation," he said.

He added that the board had restricted in publishing the name of the best candidate, noting that this was to guide against Mmesomma's saga in its examination in 2023.

Professor Oloyede explained that in the course of the examination, 25 sessions experienced hiccups of disrupting only 150 of the total 9, 156 sessions in 95 of the 774 centres

He said the affected sessions were promptly rescheduled, stating that only one centre, Makama School of

Technology, Old Motor Park, along FCCE Road, Bichi, Kano State, was de-listed for substandard performance.

He urged candidates to check their results starting from 7am on April 30 by sending UTMERESULT to 55019 or 66019.

One of the novel ideas implemented by JAMB had been the adoption of technology leading to the prompt and timely release of its UTME over the last couple of years.

CALL FOR MEMORANDA FROM THE PUBLIC

- Following the recent publication of allegations of certificate racketeering involving some foreign institutions, especially in Cotonou, Benin Republic and other countries, the Federal Ministry of Education has constituted an Inter-Ministerial Committee to investigate the allegations with a view to providing lasting solutions to the problem. The Committee was inaugurated by the Honourable Minister of Education on Tuesday, 9th January, 2024 with the following Terms of Reference:
 - ١. Examine the veracity of the allegations of degree certificate racketeering within both foreign and local private universities in Nigeria;
 - Review the role of any MDA or its officials (including identifying such officials) in the facilitation ii. of the recognition and procurement of the fake certificate in question;
 - iii. Review existing policies and procedures related to accreditation and certification to identify weaknesses contributing to the issue;
 - iv. Examine the rules, procedures and processes for recognition and accreditation of foreign universities and programmes by the Federal Ministry of Education;
 - Establish if unapproved foreign institutions (Degree Mills) exist or not in Nigeria in whatever v. form with their identities and locations if any;
 - Make appropriate recommendations for review of any rules, procedures, and processes to vi. prevent re-occurrence and sanctions for identified erring officials;
 - vii. Make other recommendations that will strengthen the system of recognition, accreditations and quality assurance of degrees in Nigeria;
 - Examine the extant rules, procedures and processes for granting provisional licenses to new viii. universities by the National Universities Commission (NUC);
 - Examine the procedures and processes for periodic accreditation of programmes in the ix. universities by NUC and examine their effectiveness in quality assurance of the programmes;
 - Without prejudice to the periodic accreditation exercise of the NUC, examine whether or not х. Private Universities established in the last 15 years have in place prescribed facilities, appropriate management structure, adequate funding of programmes, requisite staff (nature of staff – full-time, contract, adjunct, visiting, other types).
- Memoranda from the general public are, therefore, solicited to provide information to the Committee to help it make appropriate recommendations to address the menace in line with its Terms of Reference and any other information that will be useful to the Committee. Submission should be forwarded in soft copy to the Committee's email: fakecertcommittee@education.gov.ng not later than 25th March, 2024.

RE: ABOUT 100 FAKE PROFESSORS JUST UNCOVERED IN NIGERIAN UNIVERSITIES – NUC **A REBUTTAL**

The attention of the National Universities Commission (NUC) has been drawn to news items, circulating on the social media, some national dailies and television stations, to the effect that the Commission has just "discovered over 100 fake Professors in Nigerian Universities". The NUC wishes to deny these media reports categorically and unequivocally. They are fake, untrue and a figment of the imagination of the author(s), all happening at an unsuitable time, when the nation is awaiting the outcome of the investigation into the fake certificate saga from universities in some neighbouring countries. The Commission therefore finds this development as unfair to all stakeholders.

Specifically, the fake news items have been circulating in two forms – (i) as a link to a 2019 online news item; and (ii) as a separate list of names of the alleged fake Professors in various Nigerian Universities, which was not the case. We consider these unfounded publications as ill-conceived and a ploy by unscrupulous persons to create in plausible a tone, disquiet, panic and provoking outcries at both the national and international levels.

For the avoidance of doubt, the Commission can confirm that it initiated in 2019 a laudable project, with the intent of compiling and publishing a list of full Professors in the Nigerian Universities System (NUS) through the use of an online portal to collate the requisite data. During the exercise, the NUC found anomalies, such as Associate Professors being listed as full Professors. It is essential to also state clearly that the Commission as a responsible Federal Government Agency, does not engage in half-baked exercises capable of tarnishing the image of Nigeria and the NUS. That was why the Commission deemed it necessary to share the collated data with the Nigerian Universities for the purpose of authentication by the competent authourities as to who qualifies to be a full professor. Based on the verified data, the Commission then in a landmark accomplishment, first published the list of full Professors who participated in the exercise in 2019. It was understood that this would be succeeded by a continuous process of updating the list of full Professors. It is important to state at this point that all the issues pertaining to the 2019 verification of full Professors in Nigerian Universities were concluded in 2019. Since then, the Commission has entrenched a more reliable system of generating the list of full Professors in the NUS. The Commission is also conscious of the fact that some of the academics not captured in the 2019 exercise may now have matured and progressed to become full Professors; this being the reason why it continuously updates the list of full Professors in the NUS.

The National Universities Commission questions the rationale behind recycling this stale 2019 news of an activity it initiated, conducted and laid to rest in the same year. The purpose and objective of resurrecting in 2024 (more than 4 years later) this-nolonger-fresh news, is clearly intended to generate unnecessary controversy at an unsuitable time, whilst lacing it with a false list of fake Professors.

The National Universities Commission owes it a solemn duty to protect and guard the integrity of the many hardworking and committed academics in the NUS, who have earned national and international respect and recognition. Therefore, the Commission has been saddled with the vital and strategic responsibility by its enabling laws, to uphold the sanctity of quality in all aspects of our University Education delivery.

The Commission wishes to use this medium to advise Government officials at all levels, members of the NUS, the international community, and the public, to please disregard these items of fake and stale news which have long been laid to rest in 2019. Press Release SUSPENSION OF EVALUATION AND ACCREDITATION OF DEGREE CERTIFICATES FROM THE BENIN AND TOGO REPUBLICS.

The attention of the Federal Ministry of Education has been drawn to the commendable work of investigative journalism that led to the publication by the Daily Nigerian Newspaper dated 30th December 2023 titled "UNDERCOVER: How DAILY NIGERIAN reporter bagged Cotonou varsity degree in 6 weeks, participated in NYSC scheme". This was also carried in various social media.

- 2. This report lends credence to suspicions that some Nigerians deploy nefarious means and unconscionable methods to get a Degree with the end objective of getting graduate job opportunities for which they are not qualified.
- The Federal Ministry of Education vehemently decries such acts and with effect from 2nd January 2024 is suspending evaluation and accreditation of degree certificates from Benin and Togo Republics pending the outcome of an investigation that would involve the Ministry of Foreign Affairs of Nigeria and the two countries, the ministries responsible for Education in the two countries as well the Department of State Security Services (DSSS), and the National Youths Service Corps (NYSC). The Ministry therefore wish to call on the General Public to support its efforts, show understanding and provide useful information that will assist the Committee in finding lasting solutions in order to prevent further occurrence.
- The Ministry has also commenced internal administrative processes to determine the culpability or otherwise of her staff for which applicable Public Service Rules would be applied.

- The issue of degree mills institutions, i.e institutions that exist on 5. paper or operate in clandestine manner outside the control of regulators is a global problem that all countries grapple with. FME has been contending with the problem including illegal institutions located abroad or at home preying on unsuspecting, innocent Nigerians and some desperate Nigerians who deliberately patronize such outlets. Periodically, warnings have been issued by the Ministry and NUC against the resort to such institutions and in some instances, reports made to security agencies to clamp down on the perpetrators. The ministry will continue to review its strategy to plug any loopholes, processes and procedures and deal decisively with any conniving officials.
- The Ministry had always adopted the global standard for evaluation 6. and accreditation of certificates of all forms which relies on receipt of the list of accredited courses and schools in all countries of the World.
- The Ministry wishes to assure Nigerians and the general public that, it is already putting in place mechanisms to sanitise the education sector, 7. including dissuading the quest for degree certificates (locally or from foreign countries) through a re-invigorated focus on inclusivity: reliance on all skill sets as directed by President Bola Ahmed Tinubu GCFR.
- The Federal Ministry of Education is committed to collaborating with stakeholders, including civil society organizations, to consistently enhance the Nigerian education system and we value the public's understanding and patience as we strive to address these issues.
- The Federal Ministry of Education wishes all Nigerians a happy new 9. year. A year in which we would all work together to strengthen our education sector.
